## Privacy Notice

Rockwell Green Primary School needs to use data on pupils in order to be able to safeguard them and deliver the best education possible. Only essential data is held and there are clear processes in place that govern how we collect, use, store and share the data.

You have a legal right to be informed about how our school uses any personal information that we hold about you. This privacy notice explains how we collect, store and use personal data about your child.

We, Rockwell Green School are the 'data controller' for the purposes of data protection law.

Our Data Protection Officer (DPO) is Amy Brittan (see 'Contact us' on the last page).

### **The personal data we hold**

We hold some personal information about you to make sure we can help you learn and look after you when you attend our School.

For the same reasons, we get information about children from some other places too – like other schools, the local council and the government.

This information includes but is not limited to:

- Your contact details
- Assessments of your work
- Your attendance records
- Your characteristics, like their ethnic background or any special educational needs
- Medical conditions
- Details of any behaviour issues or exclusions
- Photographs
- Details of where the pupils go when they leave us

## The personal data we hold about our parents

We hold some personal information about your parents to make sure we can help you learn and look after you at school

- Contact details
- We may also hold some information about our parents if we have a safeguarding folder

## Why we use this data

We use this data to help run the school, including to:

- Get in touch with parents/carers when we need to
- Check how each pupil is progressing with their learning and what the next steps might be
- Provide remote learning opportunities during periods of lockdown
- Track how well the school as a whole is performing
- Look after each pupil's wellbeing

## Our legal basis for using this data

Under the UK General Data Protection Regulation (UK GDPR), the lawful bases we rely on for processing your information are:

- We need to comply with the law (Article 6 (1) © of UK GDPR)
- We need to use it to carry out a task in the public interest (in order to provide children with an education) (Article 6 (1) © of UK GDPR)

Sometimes, we may also use pupil's personal information where:

- You or your parents/carers have given us permission to use it in a certain way
- We need to protect a pupil's interest (or someone else's interest) e.g. in a life-or-death situation (Article 6 (1) © of UK GDPR)

We may also collect and use information about your health or other protected characteristics such as your religion or ethnicity. These are special categories of personal information, and we will only collect and use it when it is necessary for public health, e.g. protecting against serious threats to health. The legal basis here is *Article 9(2)(i) of UK GDPR*

Public Health England also has special permission from the Secretary of State for health and Social care to use personally identifiable information without your permission where there is a public interest. This is known as 'Section 251' approval and includes the use of the information collected by NHS test and Trace to help protect the public from coronavirus. The part of the law that applies here is Section 251 of the National Health Service Act 2006 and the associated Health Service (Control of Patient Information) regulations 2002

Where we have got permission to use pupil's data, parents/carers may withdraw this at any time. We will make this clear when we ask for permission and explain how to go about withdrawing consent.

Some of the reasons listed above for collecting and using pupil's information overlap, and there may be several grounds which mean we can use this data.

## Collecting this information

While in most cases parents/carers, must provide the personal information we need to collect, there are some occasions when you can choose whether or not to provide the data. We will always tell you if it's optional. If you must provide the data, we will explain what might happen if they don't.

## Data sharing

We do not share personal information about pupils with anyone outside the school without permission from parents/carers, unless the law and our policies allow us to do so.

Where it is legally required, or necessary for another reason allowed under data protection law, we may share personal information about pupils with:

Who we share with	Why we share
Our local authority	To meet our legal duties to share certain information with it, such as concerns about pupils' safety and exclusions
The Department for Education	We have to do this by law. This data sharing underpins school funding, educational policy and funding
Family and pupil representatives	To ensure that they know how the pupil are doing and to protect their welfare
Other schools after you leave our school	We will transfer your pupil record, which consists of basic information, assessment data, any educational support, and any safeguarding records. We may share some information in advance if it will enable your next school to provide effective and timely support
Police forces, courts, tribunals and security services	As we are required to by law
Educators and examining bodies	To ensure that pupils are entered for exams and that the results are recorded
Health and social welfare organisations	Such as the school nurse and the Education Welfare Officer to help look after pupils health and wellbeing
Our payment service providers	So that you can pay for meals, trips, resources and activities.
Providers of electronic learning resources	To allow pupils to use their resources in class and at home

## **International transfers of personal data**

We have audited where we store all the personal data processed in the school and by third party services. If a third-party service stores data in the EU or US, we have ensured that safeguards such as standard contractual clauses are in place to allow the safe flow of data to and from school.

## **How we store this data**

We will keep personal information about you while you are a pupil at our school. We may also keep it after you have left the school, where we are required to by law. If you leave us mid-year or move to a new school, we will transfer your pupil record to your next setting.

Our record retention schedule/records management policy is based on the [Information and Records Management Society's toolkit for schools](#) and sets out how we keep information about pupils.

## **Your rights**

### **How to access personal information we hold about you**

You can find out if we hold any personal information about you, and how we use it, by making a 'subject access request', Your parents may make this request on your behalf. If we think you are able to understand your rights and what they mean, we may ask your permission before providing information to your parents.

### **If we do hold information about you, we will:**

- Give you a description of it
- Tell you why we are holding and using it, and how long we will keep it for
- Explain where we got it from, if not from you or your parents
- Tell you who it has been, or will be, shared with

### **Your other rights over your data**

You have other rights over how your personal data is used and kept safe, including the right to:

- Say that you don't want it to be used if this would cause, or is causing, harm or distress
- Stop it being used to send you marketing materials
- Say that you don't want it used to make automated decisions (decisions made by a computer or machine, rather than by a person)
- Have it corrected, deleted or destroyed if it is wrong, or restrict our use of it
- Claim compensation if the data protection rules are broken and this harms you in some way
- Let you know if we are using your data to make any automated decisions (decisions being taken by a computer or machine, rather than by a person)

You may also ask us to send your personal information to another organisation electronically in certain circumstances. If you want to make a request, please contact our data protection officer (see 'Contact').

## Complaints

We take any complaints about how we collect and use your personal data very seriously, so please let us know if you think we've done something wrong.

You can make a complaint at any time by contacting our data protection officer.

## Appendix:

### How Government uses your data

The pupil data that we lawfully share with the Department for Education (DfE) through data collections:

- underpins school funding, which is calculated based upon the numbers of children and their characteristics in each school.
- informs 'short term' education policy monitoring and school accountability and intervention (for example, school GCSE results or Pupil Progress measures).
- supports 'longer term' research and monitoring of educational policy (for example
- how certain subject choices go on to affect education or earnings beyond school)

### The National Pupil Database (NPD)

Much of the data about pupils in England goes on to be held in the National Pupil Database (NPD).

The NPD is owned and managed by the Department for Education (DfE) and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform independent research, as well as studies commissioned by the Department for Education (DfE).

It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

## Sharing by the Department for Education (DfE)

The law allows the Department for Education (DfE) to share pupils' personal data with certain third parties, including:

- schools and local authorities
- researchers
- organisations connected with promoting the education or wellbeing of children in England
- other government departments and agencies
- organisations fighting or identifying crime

## How to find out what personal information the Department for Education (DfE) holds about you

Under the terms of the [Data Protection Act 2018](#), you are entitled to ask the Department for Education (DfE):

- if they are processing your personal data
- for a description of the data they hold about you
- the reasons they're holding it and any recipient it may be disclosed to
- for a copy of your personal data and any details of its source
